ORDER:

In the Government Order first read above, orders were issued according administrative sanction for a sum of Rs.231.76 lakh (60% Government of India share - Rs.139.06 Lakh + 40% State share Rs.92.70 Lakh) and financial sanction for a sum of Rs.151.76 Lakh under General Component towards second instalment for implementation of National e-Governance Plan for Agriculture (NeGP-A) for the year 2018 – 2019 as detailed below subject to the condition that online farmer / farm data base on dynamic platform should be created:-

Further, it was also ordered therein that orders regarding financial sanction of Rs.80.00 Lakh under Scheduled Caste component will be issued separately.

- 2. Now, the Director of Agriculture in his letter second read above has informed that in para No.9(III) of the Government Order first read above, he has been authorized to withdraw the above sanctioned amount and deposit the same in NeGP-A account kept with Tamil Nadu Watershed Development Agency. Accordingly, a sum of Rs.151.76 lakh has been withdrawn and deposited in NeGP-A account kept with Tamil Nadu Watershed Development Agency. However, the earmarked activities can be carried out once the receipt of remaining funds of Rs.80 lakh allocated under Scheduled Caste Component and requested the Government to accord financial sanction for a sum of Rs.80.00 lakh under Scheduled Caste Component to carry out the above activities.
- 3. The Government, after careful examination of the proposal of the Director of Agriculture, hereby accord financial sanction for a sum of Rs.80.00 Lakh (Rupees Eighty Lakh only) under Scheduled Caste Component towards second instalment of National e-Governance Plan for Agriculture (NeGP-A) for the year 2018 2019 to be implemented in 2019-20.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following new Head of Account:-

2401-00 Crop Husbandry – 793 – Special Central Assistance for Scheduled Caste Component Plan – Schemes shared between State and Centre – UX National e-Governance plan in Agriculture and National Mission on Agricultural extension Technology under Special Component Plan for Scheduled Caste – 309 – Grants-in – Aid – 03 – Grants for Specific Schemes.

5. The Director of Agriculture is the Estimating, Reconciling and Controlling Authority for the above new head of account.

- 6. Necessary additional funds of Rs.80.00 lakh will be provided in Revised Estimate / Final Modified Appropriation 2019-2020 under the relevant head of account. Pending provision of such funds, the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para 3 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate 2019-2020. The Director of Agriculture is directed to include this expenditure while sending the proposal for Revised Estimate / Final Modified Appropriation 2019-2020 and also to send necessary draft explanatory notes for including the above expenditure in the Supplementary Estimates 2019-2020 to Government in Finance (BG-1/Agri) Department at the appropriate time without fail.
