ORDER:

Sub Mission on Agricultural Mechanization (SMAM), a Centrally Sponsored Scheme, is being implemented in the State since 2014-2015, as per the guidelines of Government of India in the sharing pattern of 75:25. The Government of India has modified the sharing pattern from 75:25 into 60:40 from the year 2015-2016.

- 2. In the reference letter 1st read above, the Govt. of India had given permission for revalidation of unspent balance of Rs.1990.22 Lakh released for implementation of various components for its utilization during 2020-21. Accordingly, Orders have been issued vide Government Order 2nd read above for the implementation of Sub Mission on Agricultural Mechanization for the year 2020-21 for the unspent amount of Rs.3317.03 Lakh (Rs.1990.22 Lakh as GOI Share and Rs.1326.81 Lakh as State share) of the year 2019-20.
- 3. The cumulative Utilization Certificate for the amount of Rs.11667.00 Lakh (Rs.7000 Lakh as GOI share and Rs.4667.00 Lakh as State share) out of the released amount of Rs.11667.00 Lakh for the year 2019-20 towards the implementation of Sub Mission on Agricultural Mechanization was sent to Government of India along with progress report vide Chief Engineer (Agricultural Engineering), Letter No. AM 1/10387/2020(1), Dated: 28.09.2020.
- 4. In the letter 3rd read above, the Government of India had approved the component No.6 of SMAM guidelines for the Promotion of Farm machinery banks at village level towards the implementation of Krishi Kalyan Abhiyan-III in the Aspirational Districts namely, Virudhunagar and Ramanathapuram and released an amount of Rs.211.20 Lakh for General Category amounting to a total value of Rs.352.00 Lakh

for the implementation of Krishi Kalyan Abhiyan-III under Sub Mission on Agricultural Mechanization (SMAM) during the year 2020-21. The corresponding State share is Rs.140.80 Lakh for General Category.

- 5. In the Government Order 4th read above, the Government of Tamil Nadu had issued orders for the implementation of Krishi Kalyan Abhiyan-III under Sub Mission on Agricultural Mechanization for the year 2020-21 for the total outlay of Rs.352.00 Lakh Agricultural Mechanization for the year amount of Rs.211.20 Lakh and which includes the Government of India share amount of Rs.140.80 Lakh.

In the Government Order 8th read above, orders have been issued for the implementation of Sub Mission on Agricultural Mechanization for the year 2020-21 for the total outlay of Rs.7470.85 Lakh which includes the Govt.of India share amount of Rs.4482.51 Lakh and State share amount of Rs.2988.34 Lakh.

- 10. The Utilization Certificate for an amount of Rs.12014.23 Lakh (Rs.7208.538 Lakh as GOI share and Rs. 4805.692 Lakh as State share) out of the total released amount of Rs.14489.52 Lakh (Rs. 8693.712 Lakh as GOI share and Rs. 5795.808 Lakh as State share) including Krishi Kalyan Abhiyan III for the year 2020-21 towards the implementation of Sub Mission on Agricultural Mechanization was sent by Chief Engineer (Agricultural Engineering) to Government of India, along with the corresponding progress reports upto 31.03.2021 vide his letter 9th read above.
- 11. The Chief Engineer (Agricultural Engineering) has stated that there is a savings amount of Rs.1.10 Lakh (Rs.352.00 Lakh Rs.350.90 Lakh) under General Category towards the implementation of Krishi Kalyan Abhiyan-III during the year 2020-21 which may also be utilized for the distribution of individual machinery during the year 2021-22. Hence there is a total unspent amount of Rs.2475.29 Lakh during the year 2020-21.
- 12. Out of the total unspent amount of Rs.2475.29 Lakh, an amount of Rs.1945.51 Lakh is the unspent amount available under General Category and an amount of Rs.529.78 Lakh is the unspent amount available under Special Component Plan for scheduled caste farmers.
- 13. The unspent balance amount was surrendered to Government under the respective Head of Accounts during the year 2020-21 due to non-payment of total cost of machinery by delay in getting the bank loan by the farmers and the Model Code of Conduct for the Tamii Nadu Legislative Assembly Election -2021. Totally an amount of Rs.2475.29 Lakh has not been utilized during the year 2020-21 and the same will be utilized in the year 2021-22 under Sub Mission on Agricultural Mechanization Out of the total unspent amount of Rs.2475.29 Lakh, the Central share is Rs.1485.17 Lakh and Rs.990.12 Lakh is the State share
- 14. In the letter 9th read above, a revalidation proposal for the approval of utilizing the unspent amount of Rs.2475.29 Lakh (Rs.1485.17 Lakh as GOI share and Rs.990.12 Lakh as State share) during 2020-21 was sent to Govt. of India.
- 15. The Government of India, in it's letter 10th read above, have revalidated the Govt. of India share of Rs.1485.17 Lakh, for the utilization of unspent amount of Sub Mission on Agricultural Mechanization-2020-21 during the year 2021-22.
- 16. Out of the total unspent amount of Rs.2475.29 Lakh, an amount of Rs.1847.71 Lakh is proposed for the **Financial Assistance for procurement of Agricultural Machinery and Equipment through DBT portal** including the fractional savings amount of other components.
- 17. Hence, the Chief Engineer (Agricultural Engineering), has proposed to utilize the balance unspent amount of Rs.2475.29 Lakh as per the components indicated in the Annexure to this order during the year 2021-22 towards the implementation of Sub Mission on Agricultural Mechanization as per the components in the Annual Action

Plan by altering the physical target as per the farmer's current demand duly following the SMAM guidelines.

18. For General Category farmers- Rs.1945.51 Lakh

The Chief Engineer (Agricultural Engineering), is permitted to utilize the unspent amount available under the Financial Assistance for procurement of Agricultural Machinery and Equipment, i.e., 415 Nos. for Tractors, Combine Harvesters, Power Tillers, Multi Crop threshers, Balers, Rotavators Sugarcane thrash Cutters, Coconut Frond chopper and Power Weeders 21 Nos.of Establishment of Farm Machinery Banks for Custom Hiring (Upto Rs.25.00 Lakh), 46 Nos. of Promotion of Farm machinery banks at village level, 1 No. of Hi- Tech, High Productive Equipment Hub for Custom Hiring under General Category for an amount of Rs.1945.51 Lakh. Hence, an amount of Rs.1945.51 Lakh is allotted to the Agricultural Engineering Department for the year 2021-22 under the respective Head of Account.

19. For Special Component Plan for Scheduled Caste farmers - Rs. 529.78 Lakh

Further, the Chief Engineer (Agricultural Engineering) is permitted utilize the total unspent amount available under the SC category farmers under the Financial Assistance for procurement of Agricultural Machinery and Equipment, i.e., 172 Nos. for Tractors, Combine Harvesters. Power Tillers, Multi Crop threshers, Balers, Rotavators, and Power Weeders for an amount of Rs. 529.78 Lakh under SC Category during the year 2020-21. Hence, an amount of Rs.529.78 Lakh is allotted to the Agricultural Engineering Department for the year 2021-22 under the respective Head of Account.

- 20 Hence, the Chief Engineer (Agricultural Engineering) has requested the Government to revalidate and accord financial sanction and to give authorization for an amount of Rs.2475.29 Lakh (Rs.1485.17 Lakh as GOI share and Rs.990.12 Lakh as State share) under the respective head of accounts towards the implementation of the scheme of "Sub Mission on Agricultural Mechanization" during the year 2021-22.
- 21. The Government after careful examination, of the proposal of the Chief Engineer (Agricultural Engineering), considering that and an amount of Rs.1485.17 Lakh has been revalidated by the Government of India, in the letter tenth read above, hereby accord sanction for a sum of Rs.2475.29 Lakh (Rs.1485.17 Lakh as GOI share and Rs.990.12 Lakh as State share) towards implementation of the scheme of "Sub Mission on Agricultural Mechanization" during the year 2021-22.
