ORDER:-

In the Government order first read above, Government have sanctioned the continuance of the scheme for Blue Green Algae for the period from 1.4.2014 to 31.3.2015 at a cost of Rs.22.506 lakhs.

- 2. The Director of Agriculture in his letter second read above has requested the Government to issue orders for sanction of continuance of the scheme for Blue Green Algae for the period from 01.4.2015 to 31.3.2016 at a total cost of Rs.33.91 lakhs for production and distribution of 525 MT Blue Green Algae.
- 3. The Director of Agriculture has also stated that as nowadays priority is given for Organic farming, the continuance of the above scheme is necessary, since it is very much beneficial to the farming community. The soil fertility is also increasing by using the Blue Green Algae.
- 4. The Government after careful examination have accepted the proposal of Director of Agriculture. Accordingly, the Government sanction a sum of Rs.29.70 lakhs (Rupees Twenty Nine lakhs and Seventy thousand only) for production and distribution of Blue Green Algae at physical target of 525 MT and to permit to continue the scheme for the period from 01.04.2015 to 31.03.2016 subject to recover the expenditure in full through sale price.
- 5. The above expenditure shall be debited to the following head of account:-
 - " 2415-Agriculture Research and Education 01-Crop Husbandry-004 Research I Non-Plan BE-Production and Distribution of Blue Green Algae".

6. The sale of Blue Green Algae shall be credited to the following receipt head of account:-

- 7. The Director of Agriculture is directed to send the progress report to Government periodically.
