### ORDER:-

In the Government Order first read above, orders were issued for continuance of "Bio-Fertilizer Quality Control Laboratory, Trichy" for the period from 01.04.2014 to 31.03.2015.

2. The Director of Agriculture in his letter second read above, has sent proposal to the Government to issue orders for continuance of the scheme of "Bio-Fertilizer Quality Control Laboratory, Trichy" for the period from 01.04.2015 to 31.03.2016, so as to achieve the following objectives:-

- i. The "Bio-Fertilizer Quality Control Laboratory, Trichy" is to be monitoring/testing the quality of 445 number of bio-fertilizer samples produced by the State owned Bio-Fertilizer Production Units and 600 bio fertilizer samples sent by Agricultural Extension Centers are to be tested.
- ii. To produce and distribute Bio-fertilizers to farmers continuously.
- iii. To maintain the quality of Bio-fertilizers.
- iv. To find out variety of potential bio-fertilizers and to produce mother seed.
- v. To have research on rules needed for production of Bio-fertilizers at minimum cost.

3. The Government after careful examination accepts the proposal of the Director of Agriculture, accordingly the Government permit to continue the scheme of "Bio-fertilizer Quality Control Laboratory, Trichy" for a further period from 01.04.2015 to 31.03.2016 and accord sanction for Rs.17.39 lakh (Rupees Seventeen lakhs and thirty nine thousands only) as detailed in the annexure to this order towards the implementation of the said scheme during 2015-2016 subject to meet out the expenditure within the provision made in Budget Estimate 2015-2016.

4. The expenditure in respect of the continuance of the above scheme shall be debited to the following head of account:-

"2435-Other Agricultural Programmes - 01- Marketing and Quality Control - 102. Grading and Quality Control facilities - I Non-Plan-AN-Quality Control Laboratory for Bio-fertilizers".

5. The amount realized towards the scheme shall be credited to the following head of account:-

"0401-00-Crop Husbandry-800-Other Receipts-AS Miscellaneous Schemes". (DPC 0401-00-800-AS-0007)

6. The Director of Agriculture is directed to send quarterly progress reports to Government for the implementation of above said scheme, without fail.
