In the reference first cited, inter alia Government have sanctioned a sum of Rs.3,50,82,667/- (Rupees three crores fifty lakhs eighty two thousand six hundred and sixty seven only) (Government of India share Rs.2,23,93,667/- + State share Rs.1,26,89,000/-) for the implementation of National e-Governance Plan in Agriculture(NeGP-A) under the New Centrally Sponsored Scheme of National Mission on Agricultural Extension Technology (NMAET) in Tamil Nadu during 2014-15.

2. In the reference second cited, the Director of Agriculture has stated that in the Government Order first cited it has been indicated that this item is a "New Service" and the approval of the Legislature shall be obtained in due course. Necessary required provisions shall be directly included in the

Supplementary Estimate 2014-15. He has informed that necessary funds has not been provided in the said Government Order. He has therefore requested to provide financial sanction of Rs.3,50,82,667/- (Government of India share Rs.2,23,93,667/- + State share Rs.1,26,89,000/- for the Implementation of National e-Governance Plan in Agriculture (NeGP-A) under the New National Mission on Agricultural Extension and Technology during 2014-15.

3. The Director of Agriculture has requested to issue necessary fund availability to draw the sanctioned amount.

4. Accordingly, Government have permitted the Director of Agriculture to incur an expenditure of Rs.3,50,82,667/- (Rupees three crores fifty Lakhs eighty two thousand six hundred and sixty seven only) (Government of India share Rs.2,23,93,667/- + State share Rs.1,26,89,000/-) towards the implementation of National e-Governance Plan in Agriculture (NeGP-A) under the New Centrally Sponsored Scheme of National Mission on Agricultural Extension Technology (NMAET).


5. The expenditure permitted in para 4 above shall be debited to the following head of account:-

2401-00- Crop Husbandry – 109 Extension and Farmers Training Schemes in the Twelfth Five Year Plan – VI-Schemes shared between State and Centre UD – National e-Governance Plan in Agriculture under National Mission on Agricultural Extension Technology – 09- Grants in aid - 03 Grants for specific schemes (DPC 2401-00 - 109 – UD - 0934)

6. Necessary funds will be provided in Revised Estimate/Final Modified Appropriation 2015-2016. Pending provision of such funds, the Director of Agriculture is authorized to draw and disburse the amount permitted in para 4 above. He is also requested to include this expenditure while sending Revised Estimate /Final Modified Appropriation 2015-2016 proposal to Government in Finance (Agriculture) Department.
