ORDER:

During the year 2015-16, the Integrated Watershed Management Programme (IWMP) projects under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) has been proposed to be implemented in the funding pattern of 50:50.

2. In the letter 1st read above, the Government of India, have sanctioned 1st installment of a sum of Rs.3870.00 lakhs (Rupees Three Thousand Eight Hundred and Seventy lakhs only) to Tamil Nadu under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) "Other Interventions" as a Central Share for implementing water conservation, water

harvesting, works for ground water recharge specially in the frequently drought affected district / areas and most vulnerable & over exploited Block / Taluks notified by Central Ground Water Board (CGWB) in the State during 2015-16 as follows.

- 3. In the letter 2nd read above the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has stated that Government of India, have informed that the activities are to be implemented by the State Level Nodal Agency (SLNA) for Integrated Watershed Management Programme (IWMP) in the State of Tamil Nadu. It has been specified in the Operational Guidelines of Pradhan Mantri Krishi Sinchayee Yojana (Para No. 6.0) that Technical requirements / standards, pattern of assistance for activities of Pradhan Mantri Krishi Sinchayee Yojana (Watershed Development) will be as per the guidelines of the respective Ministries / Departments. The funding pattern of the scheme is 50% Central Share and 50% State Share. Since, the Government of India have sanctioned and released the 1st installment of 50% amount of Rs.3870.00 lakhs, the Government of Tamil Nadu have to release Rs.3870.00 lakhs as State's Share in line with the Central Share. As per the common guide lines for watershed projects 2008 (Revised Edition 2011) of Government of India, 1% amount sanctioned is to be earmarked for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.
- 4. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has stated that the 1st installment of Central Share and State Share have to be released by the

Government duly creating New Head of Account and necessary funds may be provided in the Revised Estimate 2015-16 as follows:-

- Therefore, the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has requested the Government to release and sanction a sum of Rs.7740.00 lakhs towards the Central and State matching share for implementing Pradhan Mantri Krishi Sinchayee Yojana Projects in Tamil Nadu during the year 2015-16 pending provision in the Revised Estimate / Final Modified Appropriation 2015-16, the Director of Agriculture, Chennai may be to draw the Central and State Share amount of Rs.7740.00 lakhs (Rupees Seven Thousand Seven Hundred and Forty Lakhs only) and to disburse the fund to the Chief Executive Officer, State Level Nodal Agency for depositing in the savings bank account opened for the purpose and further release to District Watershed Development Agencies of concerned districts for implementation of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) "Other Interventions" as per the Pradhan Mantri Krishi Sinchayee Yojana guidelines and Common Guidelines of Government of India.
- 6. The Government after careful consideration, decided to accept the proposal of the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency, to implement the Integrated Watershed Management Programme "(Other interventions)" Water conservation, Water Harvesting works etc. under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in sharing pattern of 50:50 basis at a total cost of Rs.7740.00 lakhs and accord sanction for release a sum of Rs.3870.00 lakhs (Rupees Thirty eight crore and Seventy lakhs only) as Central assistance for implementation of Integrated Watershed

Management Programme Projects in Tamil Nadu under Pradhan Mantri Krishi Sinchayee Yojana "Other interventions" sanctioned during the year 2015-16. As per the guidelines, 1% of the amount sanctioned above shall be utilized for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects. State Government share will be released separately.

- 7. The amount sanctioned in para 6 above shall be debited to the following Head of Account:-

 - "2501 Special Programmes for Rural Development 05 Watershed Development 796 Tribal Area Sub Plan Schemes in the Twelfth Five year Plan VI Schemes shared between State and Centre UA Integrated Watershed Management Programme 09 Grants in –aid 03 Grants for specific Schemes" (DP code 2501-05-796 -UA- 0939) Rs.43.00 lakhs
- 8. Necessary additional funds of Rs.3870.00 lakhs will be provided in Revised Estimate / Final Modified Appropriation 2015-16 under the relevant head of accounts. However this expenditure shall be brought to the notice of the Legislature by way of Specific Inclusion in Final Supplementary Estimate 2015-16. Pending provision of such funds, the Director of Agriculture is authorized to draw and disburse the amount sanctioned in para 6 above. He is also requested to include this expenditure while sending the proposal for Revised Estimates / Final

Modified Appropriation 2015-16 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2015-16 to Government in Finance (Agri/BG-I) Department at the appropriate time without fail.

- 9. The Director of Agriculture is hereby authorized to draw and disburse the said amount to the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency for further release of funds to Project Officer/Joint Director of Agriculture of District Watershed Development Agencies of concerned districts for the implementation of Integrated Watershed Management Programme projects as per the Common Guidelines of Government of India. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency is authorized to utilize the amount earmarked for monitoring & evaluation of Integrated Watershed Management Programme projects.
