ORDER:-

In the Government Order first read above, orders were issued enhancing the processing and tagging charges for seeds from 40 paise per Kg to 60 paise per Kg with immediate effect for the forthcoming next 3 years.

In his letter third read above, the Commissioner of Agriculture has stated that based on the above said order, the processing and tagging charges for seeds are applied as 60 paise per Kg till 2015-16. So this issue was brought to the notice of the 2nd Governing Council Meeting of TANSEDA held on 24.02.2016 and the council has instructed to send the proposal to government to continue to adopt the charges ordered in the said Government Order. Accordingly, the Commissioner of Agriculture has requested the Government to extend the period of validity of the Government Order for further 3 more years for processing and tagging charges for seeds at 60 paise /Kg.

3.The Government after careful examination accept the proposal of the Commissioner of Agriculture and direct that the validity of the orders issued in G.O.(Ms).No.169, Agriculture (AP3) Department, dated 14.08.2012 be extended for the period of further three years.
