



ABSTRACT

Agriculture – National Agriculture Insurance Scheme – Additional claims arising out of change of notified area by the concerned Nodal Bank under Kharif 2009 – Paddy-I Crop in Thiruvannamalai District – Sanction a sum of Rs. 14,00,243/- Orders – Issued.

ORDER:

In the G.O first read above, Government have sanctioned a sum of Rs.172,07,81,984/- out of an amount of Rs.196,84,79,782/- towards the settlement of compensation for Paddy-II (Samba/Thaladi/Pishanan) 2013-2014 Season.

2) In the letter second read above, the Director of Agriculture has informed that the National Agriculture Insurance Scheme is being implemented from the year Rabi-2000 onwards in all districts of Tamil Nadu by the State Government through Agriculture Insurance Company of India Limited with the objective to provide Insurance coverage and financial support to the farmers for the notified crops in the event of failure as a result of natural calamities, pest and Diseases and to encourage the farmers to adopt progressive farming practices, high value inputs, latest technology in Agriculture for higher production. As per the guidelines of the scheme, Agriculture Insurance Company of India Limited will bear the claims upto 100% of premium for food crops and oil seeds and claim beyond 100% premium will be shared equally by Central and State Governments.

3) The Director of Agriculture has stated that the Agriculture Insurance Company of India Limited have received 2 additional declaration claims from Thiruvannamalai District Central Co-operative Bank long after the settlement of compensation to farmers for the year 2009.

4) The Director of Agriculture has stated that the Agriculture Insurance Company of India Limited has sent a proposal for two claims for an amount of Rs.14,00,242.72/- One additional claim arose due to wrong mention of Block (i.e Jawadhumalai block) for Kelur firka in declaration sent earlier by District Central Co-operative Bank. As the Kelur firka belongs to Polur block 270 farmers have been deprived of the payment of compensation. Another claim arose due to wrong entry of notified area (i.e firka) for 53 farmers as Mazhaiyur firka by District Central Co-operative Bank, Thiruvannamalai. Mazhaiyur Firka 6 farmers, Peranamallur Firka 4 farmers, Nedungunam firka 43 farmers, The certificate of change of firka was issued by Chief Regional Manager, Agriculture Insurance Company of India Limited and the compensation claim arising for the farmers of peranamallur firka and nedungunam firka was preferred by Agriculture Insurance Company of India Limited for sanction of State share of compensation.

5) The Director of Agriculture has further stated that Agriculture Insurance Company of India Limited claimed that out of a total claim of Rs.28,00,485.44 which was approved by the Government of India and the share of Government of India amounting to Rs.14,00,242.72 is available with Agricultural Insurance Company of India Limited and has therefore requested to release the balance State Government share of claims.

6) The Director of Agriculture has therefore requested the Government to sanction a sum of Rs.14,00,243/- being the State Government share of claims as detailed below:-

The Director of Agriculture has requested to authorize him to draw and disburse the amount to the Agriculture Insurance Company of India Limited, Chennai and also requested to relax the quarterly restriction of funds for early settlement of State Share of compensation to farmers.

7) The Government after careful examination accept the proposal of the Director of Agriculture and accordingly sanction a sum of Rs.14,00,243/- (Rupees Fourteen lakhs two hundred and forty three only) towards the Additional claims arising out of change of notified Block/ Firka area by the concerned Nodal Bank during Kharif 2009 - Paddy-I Crop in Thiruvannamalai District.

8) The amount sanctioned in para 6 above shall be debited to the following Heads of Account:-


