In the Government Order first read above, orders were issued according administrative approval for launching Tamil Nadu Cotton Cultivation Mission at a cost of Rs.50.00 crore during 2014-15 and sanctioned a sum of Rs.1550.04 lakh and also permitted the Director of Agriculture to dovetail the funds from National Mission for Sustainable Agriculture (NMSA) and National Food Security Mission (NFSM) at a rate of Rs.3420.00 lakh and Rs.29.960 lakh respectively.

2. In his letter second read above, the Director of Agriculture has sent proposals for permission to implement the Tamil Nadu Cotton Cultivation Mission during 2015-16 with unspent amount of Rs.4068.373 lakh which was originally sanctioned during 2014-15 as detailed below:-

- 3. The Director of Agriculture has sought for permission on the following:
  - i. NMSA On farm Water Management component fund is meant for micro irrigation and it is operated by TANHODA. For the current year 2015-16, TANHODA have informed that an amount of Rs.75.00 crore will be released for installation of drip irrigation covering all agricultural crops including cotton. Accordingly, for Tamil Nadu Cotton Cultivation Mission, it is proposed to dovetail Rs.2887.531 lakh for installation of micro irrigation system from National Mission for Sustainable Agriculture and also seeking permission to dovetail Rs.2887.531 lakh from NMSA–On Farm Water Management during 2015-16.
  - ii. Inrespect to NFSM fund, budget is operated through Tamil Nadu Watershed Development Agency. An amount of Rs.29.96 lakh was released and allocated to district Joint Directors of Agriculture and unspent amount of Rs.1.814 lakh is available with District Water shed Development Agency (DWDA) and seeking permission to utilize the unspent amount of Rs.1.814 lakhs available with district Joint Directors of Agriculture during 2015-16.
- iii. For implementing the Tamil Nadu Cotton Cultivation Mission during 2015-16, Budget Estimate of Rs.1550.04 lakh is provided and also requested necessary order to utilize an amount of Rs.1179.028 lakh.
- 4. In their letter third read above, Government of India have revalidated the unspent amount to implement Trials on High density planting system in 20 Ha at the rate of Rs.9000/Ha utilizing Rs.1.80 lakh only. Based on the above, Director of Agriculture has requested to implement the Tamil Nadu Cotton Cultivation Mission during 2015-16 with a budget outlay of Rs.4068.359 lakh as detailed in Annexure to this order.
- 5. The Government after careful examination accept the proposal of the Director of Agriculture and permission is accorded to the Director of Agriculture to utilize the unspent amount of Rs.4068.359 lakh (Rupees forty crore sixty eight lakh thirty five thousand and nine hundred only) for implementation of the scheme "Tamil Nadu Cotton Cultivation Mission" during 2015-16 which was originally sanctioned during 2014-15 as detailed in the annexure to this order. The Government also release a sum of Rs.1179.028 lakh (Rupees eleven crore seventy nine lakh and two thousand eight hundred only) and permit the Director of Agriculture to dovetail funds for drip irrigation system from PMKSY (Pradhan Manthri Krishi Sinchayee Yojana) (which was originally under National Mission for Sustainable Agriculture (NMSA)) and National Food Security Mission (NFSM) at the rate of Rs.2887.531 lakh and Rs.1.800 lakh respectively for implementation of the scheme "Tamil Nadu Cotton Cultivation Mission" during 2015-16 which was originally sanctioned during 2014-15.

6. The expenditure of Rs.1179.028 lakh sanctioned in para 5 above shall be debited to the following Head of Account:-

"2401-00-Crop Husbandry-108 Commercial Crops-Schemes in the twelfth five year plan-II State Plan-KZ Tamil Nadu Cotton Cultivation Mission-09 Grants-in-aid 03 Grants for Specific Schemes".

- 7. The Government permit the Director of Agriculture to allot target under Production and distribution of quality seeds to the Non-Government Organisation, South India Mills Association, Coimbatore and to draw and disburse the financial allocation based on the target through the Joint Director of Agriculture, Coimbatore.
- 8. The Government also permit the Director of Agriculture to draw and disburse the recurring expenditure towards Development of genotypes for High density planting system to the Comptroller, Tamil Nadu Agricultural University, Coimbatore.
- 9. The Government also permit the Director of Agriculture to utilize savings in any of the proposed component of State fund to some other needy components in order to utilize the State fund effectively without any surrender during 2015-16.
- 10. The Director of Agriculture is requested to submit the progress Quarterly report of physical and financial achievements to Government on the progress of Cotton production through Tamil Nadu Cotton Cultivation Mission.
- 11. This order issues with the concurrence of Finance Department vide its U.O.No. 46666/Agri/2015, Dated 01.10.2015.
