ORDER:

In the letter 1st read above, the Government of India have sanctioned and released a sum of Rs.3870.00 lakhs as 1st instalment in 50:50 sharing pattern for the year 2015-16 for implementation of Integrated Watershed Development Programme under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana “Other Interventions” in Tamil Nadu State. Since the Government of India have sanctioned and released 1st installment of Rs.3870.00 Lakhs to Tamil Nadu under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) “Other Interventions” as a Central Share for implementing water conservation, water harvesting, works for ground water recharge specially in the frequently drought affected district / areas and most vulnerable & over exploited Block / Taluks notified by Central Ground Water Board (CGWB) in the State during 2015-16. The Government of Tamil Nadu have to release Rs.3870.00 Lakhs in line with the Central Scheme.

2. In the Government Order 3rd read above the Government have released and sanctioned a sum of Rs.3870.00 lakhs as Central Share for Water Conservation and Water Harvesting works under PMKSY “Other Interventions” in Tamil Nadu during the year 2015-16 as per the Common Guidelines for watershed projects 2008 (Revised Edition 2011) of Government of India. Out of the above amount, 1% amount sanctioned is to be earmarked for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.

3. Now, the Government of India have revised the funding pattern of the Centrally Sponsored Scheme PMKSY which will be 60:40 between Centre and State. As such the Department of Agriculture, Co-operation and Farmers Welfare, Government of India, New Delhi have to release the Rs.4644.00 Lakhs as Central Share during 2015-16 for implementation of Integrated Watershed Management Programme (IWMP) projects under Watershed Component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) "Other Interventions" in Tamil Nadu State. The Government of India have already released Rs.3870.00 lakhs. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has sent proposal for releasing the balance 10% amount of Rs.774.00 lakhs to Government of India and orders are being expected.

4. In the letter 4th read above the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency has requested the Government to release a sum of Rs.3096.00 Lakhs towards State's share during 2015-16 in line with the Central Share for implementation of "Other Interventions" for Water Conservation and Water harvesting in the State in the revised sharing pattern as follows:-

The Government after careful consideration, decided to accept the proposal of the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency to implement the Integrated Watershed Management Programme "(Other interventions)" Water conservation, Water Harvesting works etc. under Pradhan Mantri Krishi Sinchayee Yojana during 2015-16 in sharing pattern of 60:40 basis and accord sanction for release a sum of Rs.3096.00 lakhs (Rupees Thirty crore and Ninety Six lakhs only) as State Share for implementation of Integrated Watershed Management Programme Projects in Tamil Nadu under Pradhan Mantri Krishi Sinchayee Yojana "Other interventions" sanctioned during the year 2015-16. As per the guidelines, 1% of the amount sanctioned above shall be utilized for monitoring and 1% for evaluation of Integrated Watershed Management Programme Projects.

(DP Code – 2501-05-796 -UA- 0939) – Rs.34.40 lakhs

7. Necessary provision has been provided in Revised Estimate 2015-16.

The Director of Agriculture is hereby authorized to draw and disburse the said amount to the Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency for further release of funds to Project Officer/Joint Director of Agriculture of District Watershed Development Agencies of concerned districts for the implementation of Integrated Watershed Management Programme projects as per the Common Guidelines of Government of India. The Chief Executive Officer, State Level Nodal Agency, Tamil Nadu Watershed Development Agency is authorized to utilize the amount earmarked for monitoring & evaluation of Integrated Watershed Management Programme projects.

9. This order issues with the concurrence of Finance (Agriculture) Department vide its U.O.No. 43/Secy(Exp)/2016, dated 04.02.2016.
