ORDER:

The Chief Engineer (Agricultural Engineering) (i/c) in his letter dated 14.10.2015 has stated that in order to effectively promote the new concept of mechanised paddy transplantation in delta districts and to ensure proper implementation of the scheme, the following activities are being implemented:-

- (1) Documentation (photos, writeup, etc.) of mechanized transplanting activities viz. before, during and after execution of the works and success stories;
- (2) In order to implement this new technology on large scale basis in delta districts within a stipulated time, the following modes of extension activities are being carried out to propagate this innovative technique which also involve raising up special mat nursery suitable for mechanized transplantation:-
 - i) Display of flex boards at farmers gathering points;
 - ii) Printing and distribution of handouts detailing about the scheme to delta district farmers;
 - iii) Extension activities through loud speakers;
 - iv) Organizing village meetings to propagate mechanized transplantation;
 - v) Preparation of bills, certificates and other related documents;

The approximate estimate details for the above activities are given below:-

The Chief Engineer (Agricultural Engineering) (i/c) has, therefore, requested the Government to sanction an amount of Rs.16.50 lakh towards documentation and propagating the mechanized paddy transplantation from the State fund savings amount of Rs.65.00 lakh sanctioned for the implementation of special package for kuruvai cultivation in six delta districts during the year 2015.

3. The Government after careful examination, authorize the Chief Engineer (Agricultural Engineering) to utilize the amount of Rs.16,50,000/- (Rupees sixteen lakh and fifty thousand only) towards documentation and propagating the mechanized paddy transplantation in connection with implementation of Kuruvai package assistance for 2015 in six Cauvery delta districts from the savings amount available under State Fund sanctioned in the Government Order first read above.

4. The expenditure authorized to utilize in para 3 above shall be debited to the following head of account:-
