ORDER:-

Sub Mission on Agricultural Mechanisation (SMAM), a Centrally Sponsored Scheme, is being implemented in the State since 2014-15 as per the guidelines of Government of India in the sharing pattern of 75:25. The Government of India have approved the Annual Action Plan for the year 2015-16 in the sharing pattern of 50:50 for Rs.1322.00 lakhs and allocated and released a sum of Rs.661.00 lakhs to this State for Sub Mission on Agricultural Mechanisation for as per the revised funding pattern of 50:50.

2) The Chief Engineer (Agricultural Engineering) has requested to allot an amount of Rs.1322.00 lakhs (Rs.991.50 lakhs for General Category farmers, Rs.317.28 lakhs for scheduled caste farmers and Rs.13.22 lakhs to scheduled tribe farmers) for various components under Sub Mission on Agricultural Mechanization during 2015-16 as per the following table:

- 3) In the G.O. second read above, the Government have issued orders for release of Rs.991.50 lakhs out of Rs.1322.00 lakhs for implementation of Sub Mission on Agricultural Mechanization including Government of India share of Rs.661.00 lakhs (50%) and Rs.330.50 lakhs being 25% State Government's share for the year 2015-2016 in the existing pattern
- 4) Meanwhile, the Government of India, in its letter dated 23.11.2015, has requested to prepare the Annual Action Plan (AAP) as per revised funding pattern for the components of Centrally Sponsored Schemes (CSS) to 60:40 (P.T.O)

(From existing pattern 50:50) under Sub Mission on Agricultural Mechanisation which comes under the core scheme Krishi Unnati Yojna, since the Finance Secretary, Ministry of Finance, Department of Expenditure, Government of India has revised funding pattern for the components of Centrally Sponsored Schemes (CSS) to 60:40 (Centre:State) under Sub Mission on Agricultural Mechanization (SMAM).

5) Accordingly, the Chief Engineer (Agricultural Engineering) has sent the revised financial total outlay for the implementation of Sub Mission on Agricultural Mechanization for 2015-16 is Rs.1101.67 Lakhs with the following component as per the table below:-

- 6) The Chief Engineer (Agricultural Engineering) has informed that as per revised funding pattern of Sub Mission on Agricultural Mechanization (60:40) the revised state share is Rs.440.67 Lakhs (40% of the total outlay) for the central share of Rs.661.00 Lakhs (60% of the total outlay) and the revised total outlay is Rs.1101.67 Lakhs only and requested to release the balance share of Rs.110.17 lakhs.
- 7) The Government after careful examination, have decided to accept the proposal of the Chief Engineer (Agricultural Engineering) and in partial modification of orders issued on the Government Order 2nd read above, the Chief Engineer (Agricultural Engineering) may be permitted to implement the Sub Mission on Agricultural Mechanization at the total outlay of Rs.1101.67 lakhs in the revised sharing pattern of 60:40 (Rs.661.00 and Rs.440.67 lakhs) and accord financial sanction for release of sum of Rs.110.17 Lakhs (Rupees One Crore ten lakhs and seventeen thousand only) (Rs.440.67 lakhs Rs.330.50 lakhs) being the balance amount of State Government share in the revised sharing pattern 60:40 (Rs.82.635 lakhs for general category farmers, Rs.26.440 Lakhs for special component plan for Scheduled Caste farmers and Rs.1.104 Lakhs to Scheduled Tribe farmers) for various components under Sub Mission on Agricultural Mechanization for the implementation of Sub Mission on Agricultural Mechanization during the year 2015-2016 as per the Sub Mission on Agricultural Mechanization guidelines issued by Government of India.
