



Horticulture – Training to farmers through Horticulture Training Centres during 2016-17 at an outlay of Rs.7.50 lakh – Orders – Issued

From the Principal Secretary / Commissioner of Horticulture and Plantation Crops Letter No. TRG/8322/2016, dated 21.06.2016.

ORDER:-

The Principal Secretary / Commissioner of Horticulture and Plantation Crops in his letter read above has stated that till 2014-15 the training programme was proposed under Integrated Horticulture Development Scheme (IHDS) and during this year ie. 2016-17, it is proposed under State fund directly. He has further stated that Hi-tech training in Horticulture crop cultivation viz, precision farming, protected cultivation, high-density planting, canopy management, pest and disease management, irrigation and fertigation are imparted to the farmers through the Horticulture Training Centres functioning at Kudimianmalai, Madhavaram, Thally and Ooty. It is proposed to impart training to 3000 farmers at an outlay of Rs.7.50 lakh at Rs. 250 per beneficiary. The Principal Secretary / Commissioner of Horticulture and Plantation Crops has also stated that an amount of Rs.7.50 lakh has been provided in the Budget Estimate 2016-2017 under the relevant Head of account.

- 2. He has, therefore, requested the Government to issue orders for giving training to farmers through Horticulture Training Centres during 2016-17 at an outlay of Rs.7.50 lakh under State fund and the Principal Secretary / Commissioner of Horticulture and Plantation Crops may be authorised to draw and disburse the above mentioned amount and to reallocate the physical and financial target based on the need.
- 3. The Government after careful consideration of the proposal of Principal Secretary / Commissioner of Horticulture and Plantation Crops accord sanction for a sum of Rs.7,50,000/- (Rupees Seven lakh fifty thousand only) for giving training to farmers through Horticulture Training Centres at Kudimianmalai, Madhavaram, Thally and Ooty during 2016-17.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of amount:-

2401-00-Crop Husbandry-109-Extension and Farmers Training-I-Non Plan-AH Horticulture Training Centre 72 Training.

- 5. The Principal Secretary / Commissioner of Horticulture and Plantation Crops is authorised to draw and disburse the amount sanctioned in para 3 above.
- 6. The Principal Secretary / Commissioner of Horticulture and Plantation Crops is also permitted to re-allocate the physical and financial target based on the need.
