#### ORDER:

The Government of India in their letters fifth read above have allocated Rs.2,40,18,000/- and released Rs.96,76,200/- to Tamil Nadu for implementation of National e-Governance Plan for Agriculture (NeGP-A) during the financial year 2018-2019.

2. Accordingly, in the Government Order sixth read above, administrative and financial sanction was accorded for a sum of Rs.161.27 lakh (60% Government of India share - Rs.96.762 Lakh + 40% State share Rs.64.508 Lakh) towards implementation of National e-Governance Plan for Agriculture (NeGP-A) during the

year 2018 – 2019 as detailed below subject to the condition that online farmer / farm data base on dynamic platform should be created :-

- 3. The Government of India in their letters seventh read above have sanctioned and released Rs.1,39,06,000/- (Rs.91,06,000/- as 2<sup>nd</sup> installment-B and Rs.48,00,000/- as 2<sup>nd</sup> installment-A) to Tamil Nadu for implementation of National e-Governance Plan for Agriculture during the financial year 2018-2019.
- 4. The Director of Agriculture in his letter eighth read has informed that the proposal is prepared by duly following National e-Governance Plan for Agriculture guidelines in the ratio of 60: 40 (Central and State) totaling Rs.231.76 lakh as detailed below:-

# I. Placement of Data Entry Operators at Block Level

It is proposed to place 192 Nos. of Computer Data Entry Operators covering 324 Blocks for a period of seven months—at a total cost of Rs.2,02,27,200/- [@ Rs.15050 per month which includes net salary of Rs.10000/- + Rs.2500/- (25 % EPF) + Rs.500/- (5 % ESI) + Rs.250/- (2.5 % service charges) + Rs.1800/- (18% GST) per Computer Data Entry Operator).

# II. Desktop computer for State Headquarters:-

As per National e-Governance Plan for Agriculture guidelines, 20 numbers of desktop computers allotted to State Agriculture Department Head Quarters. Accordingly 20 numbers of desktop computers have already been procured and installed. However, it is informed that the computer systems already supplied under AGRISNET (50 Nos.) during 2008 - 2009 are in obsolete and required to be replaced at once. Hence, 50 numbers of desktop computers along with UPS additionally proposed to State Agriculture Department Headquarters.

- 5. The Director of Agriculture has, therefore, requested the Government-
- (i) to accord administrative and financial sanction for a sum of Rs.231.76 lakh (Government of India Share: Rs.139.06 lakh + State Share: Rs.92.70 lakh) to carryout the following activities:-

(ii) to permit for the placement of Computer Data Entry Operator through approved outsourcing agencies by Support to State Extension Programme for Extension Reforms Scheme – Agricultural Technology Management Agency (SSEPERS – ATMA) Governing Board under the Chairmanship of District Collector;

- (iii) to permit him to procure Desktop Computer alongwith UPS from M/s. Electronics Corporation of Tamil Nadu Limited (or) Government e-Market Portal;
- (iv) to withdraw the entire sanctioned amount and deposit in the National e-Governance Plan for Agriculture Bank account maintained at Tamil Nadu Watershed Development Agency, Chennai-32; and
- (v) to create a new Head of Account for Scheduled Caste Component, since the Government of India has allocated the amount for Scheduled Caste component separately during this year;
- 6. The Government, after careful examination of the proposal of the Director of Agriculture, hereby accord administrative sanction for Rs.231.76 lakh (Rupees Two Crore Thirty One Lakh and Seventy Six Thousand only) (60% Government of India share Rs.139.06 Lakh + 40% State share Rs.92.70 Lakh) and financial sanction of Rs.151.76 Lakh (Rupees One Crore Fifty One Lakh and Seventy Six Thousand only) under General Component towards second instalment for implementation of National e-Governance Plan for Agriculture (NeGP-A) for the year 2018 2019 as detailed below subject to the condition that online farmer / farm data base on dynamic platform should be created:-

The District Joint Director of Agriculture shall be the official for placing the Computer Data Entry Operator pertaining to the District;
- (ii) to procure Desktop Computer alongwith UPS from M/s. Electronics Corporation of Tamil Nadu Limited (or) Government e-Market Portal; and
- (iii) to withdraw Rs.151.76 Lakh sanctioned in para 6 above and deposit the same in the National e-Governance Plan for Agriculture Bank account maintained by the Tamil Nadu Watershed Development Agency (TAWDEVA), Chennai-32;
