ORDER:

In Government Order first read above, the Government have revised the existing pattern from 80:20 to 60:40 ratio to Small and Marginal Farmers and other category farmers respectively with effect from January 2017 onwards for Micro irrigation under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY).

2. In the letter second read above, the Government of India have informed that an amount of Rs.28500.00 lakh has been tentatively allocated to State of Tamil Nadu as a Central Share for implementation of Micro irrigation under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2017-18. The scheme shall be implemented as per provisions under Operational Guidelines of Per Drop More Crop (Micro Irrigation) under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY).

3. In the letter third read above, the Government of India have released an amount of Rs.17100.00 lakh (i.e) Rs.15646.50 lakh for General Category; Rs.1282.50 lakh for SCSP Category; and Rs.171.00 lakh for TSP Category towards implementation of Micro irrigation Scheme under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2017-18 out of approved amount of Rs.28500.00 lakh.

4. In his letter fourth read above, the Director of Horticulture and Plantation Crops /Managing Director, Tamil Nadu Horticulture Development Agency has stated that the State mandatory and additional shares have to be released corresponding to the Government of India share. The details are given below: -

Hence, the Director of Horticulture and Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release the Government of India share along with matching State share for an amount of Rs.48236.25 lakh which includes Government of India share of Rs.17100.00 lakh and matching State share and additional share of Rs.31136.25 lakh (Rs.10830+Rs.20306.25) towards smooth and successful implementation of Micro Irrigation Scheme under "Per Drop More Crop" component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2017-18. He has also furnished the details of the Government of India as well as State funds allocation percentage along with the category-wise fund allocation of Rs.48236.25 lakh as detailed below:-

7. Necessary additional funds of Rs.26807.54 lakh will be provided in Revised Estimates / Final Modified Appropriation 2017-18 under the relevant head of accounts. Pending provision of such funds, the Director of Horticulture and Plantation Crops is permitted to draw and disburse the amount sanctioned in para 5 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The Director of Horticulture and Plantation Crops is requested to include this expenditure while sending the proposal for Revised Estimates / Final Modified Appropriation 2017-18 and also to send necessary explanatory notes for including the above expenditure in the Supplementary Estimates 2017-18 to Government in Finance (Agri/BG-I) Department at the appropriate time without fail.

8.The Managing Director, Tamil Nadu Horticulture Development Agency / Director of Horticulture and Plantation Crops is authorized to draw the amount sanctioned and released in para-5 above and deposit the same in the PD account of [P.T.O. . .
