2) In their letter second read above the Government of India have released a sum of Rs.148.43 lakh as its 60% share (1^{st} installment) for the implementation of National e-Governance Plan in Agriculture (NeGP-A) during 2016-17.

He has also requested to permit him to procure all computers and related peripherals excepting connectivity, through ELCOT and to withdraw the amount and deposit it into the NeGP-A bank account at TAWDEVA in order to make payment to ELCOT based on the receipt of invoice in phased manner.

4) The Government after careful examination accept the proposal of the Director of Agriculture and accord sanction for a sum of Rs.2,47,38,000/- (Rupees Two Crore Forty Seven Lakh and Thirty Eight Thousand only) (60 % Government of India share - Rs.148.43

lakh + 40% State share - Rs.98.95 lakh) as 1st installment towards the implementation of National e-Governance Plan for Agriculture (NeGP-A) during 2016-17 as detailed at para 3 above.

5) The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

- 6) Necessary additional funds will be provided in Revised Estimate/ Final Modified Appropriation 2016-2017 under the relevant head of account. Pending provision of such funds the Director of Agriculture is permitted to draw and disburse the amount sanctioned in para 4 above. However, the expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimate. The Director of Agriculture is requested to include this expenditure while sending the proposal for Revised Estimate/Final Modified Appropriation 2016-2017 and also to send necessary draft explanatory notes for including the above expenditure in the supplementary Estimates 2016-2017 to Government in Finance (Agri/BG-I) Department at the appropriate time without fail.
- 7) The Director of Agriculture is permitted to procure all computers and related peripherals excepting connectivity, through ELCOT and to withdraw the amount and deposit it into the National e-Governance Plan for Agriculture bank account at Tamil Nadu Watershed Development Agency (TAWDEVA).
