ORDER:

In the Government order first read above, orders have been issued according administrative approval for the implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) during 2019-2020 in Tamil Nadu at a cost of Rs.634.7438 crore in all the districts of Tamil Nadu (except Chennai).

2. The 45th State Level Coordination Committee on Crop Insurance meeting for notifying Rabi Crops during 2019-2020 under Pradhan Mantri Fasal Bima Yojana (PMFBY) was held on 6.11.2019 and the Committee accepted to notify the Crops, Districts, Firkas and Revenue Villages for Agricultural and Horticultural Crops, for notification of Insurance Units and publication in the State Gazette.

3. In his letter third read above, the Director of Agriculture, based on recommendation of the 45th State level Co-ordination Committee on Crop Insurance meeting to notify crops during Rabi season, 2019-2020 held on 06.11.2019 under the Chairmanship of Agricultural Production Commissioner and Principal Secretary to Government, Agriculture Department has sent the proposal for notification of Crops, Districts, Firkas, Revenue Villages, Insurance Units and Approved Premium Rates for Agriculture and Horticulture Crops during Rabi, 2019-2020 and requested the Government to issue orders and also publish the notification in the Government Gazette.

4. The Government, after careful examination of the proposal of the Director of Agriculture, accept the same and accordingly notify the Crops, Districts, Firkas, Revenue Villages, insurance units and approved premium rates for Agricultural and Horticultural Crops for the effective implementation of the Pradhan Mantri Fasal Bima Yojana during Rabi, 2019-2020 season as detailed in the Annexures I, II, III, IV and V to this order.

5. The claims under the Pradhan Mantri Fasal Bima Yojana Scheme shall be settled on the basis of yield data furnished by the Department of Economics and Statistics as per prescribed cut-off dates for the notified crops / districts / firkas / revenue villages for the effective implementation of Pradhan Mantri Fasal Bima Yojana scheme during Rabi 2019-2020 season and not on the basis of the Annavari Certificate / Gazette notification declaring the area as Drought / Flood / Cyclone affected etc., by the District Collectors.

NOTIFICATION FOR RABI SEASON 2019-2020

ANNEXURE I

[G.O.(D).No.256, Agriculture (AP2) Department, Dated: 19.11.2019]

Pradhan Mantri Fasal Bima Yojana (PMFBY) will be implemented in all the districts of Tamil Nadu (except Chennai) during Rabi, 2019 - 2020 season as per the Revised Operational Guidelines of Government of India (Government of India Letter No.13015/03/2016–Credit II, Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Co-operation & Farmers Welfare, Krishi Bhavan, New Delhi, dated 28.09.2018).

I. OBJECTIVES OF PRADHAN MANTRI FASAL BIMA YOJANA:

Pradhan Mantri Fasal Bima Yojana aims at supporting sustainable production in agriculture by way of-

- a) Providing financial support to farmers suffering crop loss/damage arising out of unforeseen events.
- b) Stabilizing the income of farmers to ensure their continuance in farming.
- c) Encouraging farmers to adopt innovative and modern Agriculture practices.
- d) Ensuring flow of credit to the agriculture sector, which will, contribute to food security, crop diversification and enhancing growth and competitiveness of agriculture sector besides protecting farmers from production risks.

II. COVERAGE OF FARMERS:

All farmers including share croppers and tenant farmers growing the notified crops in the notified areas are eligible for coverage.

- Compulsory for Loanee farmers.
- Optional for Non - Loanee farmers.

III. COVERAGE OF RISKS AND EXCLUSIONS:

The following stages of the crop and Risks leading to crop loss are covered under the scheme:

- 1. PREVENTED SOWING/ PLANTING / GERMINATION RISK** – If Insured area is prevented from sowing / planting / germination due to deficit rainfall or adverse seasonal weather conditions.
- 2. STANDING CROP (SOWING TO HARVESTING)** - Comprehensive risk insurance is provided to ***cover yield losses due to non - preventable risks viz. Drought, dry spells, flood, inundation, wide spread pests and diseases, landslides, fire due to natural causes, lightening, storm, hailstorm and cyclone.***

3. **LOCALIZED CALAMITIES** - Loss/damage to notified insured crops resulting from occurrence of **identified localized risks of hailstorm, landslide, inundation (except Paddy, Sugarcane), cloudburst and natural fire due to lightening affecting isolated farms in the notified area.**
4. **ON ACCOUNT PAYMENT OF CLAIMS DUE TO MID-SEASON ADVERSITY** - Insurance cover will be provided to the farmers to provide immediate relief in case of **adverse seasonal conditions viz. floods, prolonged dry spells, severe drought etc., during the crop season wherein expected yield during the season is likely to be less than 50% of Normal Yield.**
5. **POST-HARVEST LOSSES** - Coverage is available only upto a maximum period of two weeks from harvesting, for those crops which are required to be **dried in cut and spread / small bundled condition in the field after harvesting against specific perils of hailstorm, cyclone, cyclonic rains and unseasonal rains.**

IV. NOTIFICATION OF IMPLEMENTING AGENCY

The following Insurance Companies are notified to implement Pradhan Mantri Fasal Bima Yojana during Rabi, 2019-2020 Season in all the districts except Chennai as per the tender agreement. (Work order issued to the Insurance Companies vide- Director of Agriculture Letter No.G1/ 126094 /2018-1 dated 4.3.2019 and Contract Agreement signed between Department of Agriculture & the Insurance Companies).

V. NOTIFICATION OF CLUSTER & INDEMNITY LEVEL

The following six clusters and also the Indemnity Level indicated thereon for the purpose of calculation of Threshold yield are notified. The Indemnity Level for the purpose of calculation of Threshold yield is fixed at 90% for low risk districts, 80% for medium risk districts and 70% for high risk districts.

VI. DISTRICTS AND INSURANCE UNITS NOTIFIED FOR RABI OTHER CROPS DURING 2019- 2020 UNDER PRADHAN MANTRI FASAL BIMA YOJANA

As approved in the 45th State Level Coordination Committee on Crop Insurance meeting held on 06.11.2019, Revenue Village is notified as insurance unit for major crops and Firka for minor crops. during Rabi, 2019 – 2020 Season under PMFBY (**District wise, Crop wise list of units furnished in Annexure-II**).

- ii. 87 villages in 22 additional clusters & 12 villages in the existing Notified Units of Thanjavur, Salem, Villupuram & Madurai where Agriculture Insurance Company of India Limited is the Implementing Agency.

b. Horticulture Crops:

- i. Additional 5 Notified units (5 Revenue Villages) for Garlic and 3 Notified Units for Cabbage (8 Revenue Villages) in the Nilgiris District and 6 Notified units (11 revenue villages) for Banana crop in Thanjavur district where Agriculture Insurance Company of India Limited is the implementing agency.
- ii. Additional 6 Notified units (19 revenue villages) for Coriander crop in Ramanathapuram district where Oriental Insurance Company Limited is the implementing agency.

The Insurance Companies are also permitted to reconcile with the Department of Economics & Statistics (DES) for any discrepancies noted in the hierarchy of the notified units at any stage of implementation of the scheme during enrolment, implementation / uploading in Government portal while processing the compensation.

VII. SUM INSURED:

The Scale of Finance approved by State Level Technical Committee for the year 2019-2020 and notified vide G.O.(Ms).No.78, Agriculture (AP2) department, dated 11.04.2019 should be adopted as Sum Insured for the crops notified during Rabi, 2019-2020 season as per Para No.12.1 of the Revised Operational Guidelines of Pradhan Mantri Fasal Bima Yojana .The Sum Insured will be same for both loanee and non-loanee farmers.

VIII. CLUSTER-WISE, DISTRICT-WISE APPROVED PREMIUM RATE AND THE PREMIUM RATE FOR FARMERS FOR RABI, 2019-2020 SEASON

As approved in the tender agreement, the crop-wise, cluster-wise, district-wise approved premium rate and the premium rate for farmers are notified as per Annexure III for Rabi, 2019-2020 Season (rate of Insurance Charges payable by the farmer is 1.5% of Sum Insured or Actuarial rate, whichever is less for all food grain (Cereals, Millets & Pulses) & Oilseed crops and 5% of sum insured or actuarial rate whichever is less for Annual Commercial / Annual Horticultural crops and Perennial Horticultural Crops).

IX. NOTIFICATION OF THRESHOLD YIELD FOR THE NOTIFIED UNITS IN THE HIERARCHY AS PER NOTIFICATION

The Insurance Companies have to calculate and upload the threshold yield at Insurance unit level on the National Crop Insurance Portal. The Insurance Companies shall also furnish the Threshold yield to Government after receipt of Crop Cutting Experiment Yield data from Department of Economics and Statistics.

X. FURNISHING OF AREA SOWN DETAILS WITHIN TWO MONTHS FROM THE SOWING SEASON AND G-RETURN TWICE A YEAR

The Department of Economics & Statistics shall ensure that the reconciled (District Revenue Officer Report) Insurance Unit wise monthly area sown details which are subjected to change are furnished temporarily to the Insurance Companies by the District Deputy Director of Statistics and the final area sown details is furnished before 29th May, 2020 for Rabi season.

XI. SEASONALITY DISCIPLINE/ CUT-OFF DATE FOR RABI, 2019-2020

The cluster-wise, district-wise crop-wise seasonality discipline (Annexure IV) is notified. It is also permitted to treat the next working day as the cut-off date in

case if the cut-off date falls on a public holiday or is declared as public holiday by the Government or there is disruption of services due to strikes/shut-down etc as per the Para 16.3 of Operational Guidelines.

XII. SEASONALITY FOR FURNISHING CROP CUTTING EXPERIMENT FORM I & II AND ACTUAL YIELD DATA FOR RABI, 2019-2020

The cluster-wise, district-wise crop-wise seasonality discipline for furnishing Crop Cutting Experiment Form I & II and actual yield data by the Department of Economics and Statistics (Annexure V) are notified and permitted to adopt Para 16.3 of Operational Guidelines.

XIII. PRIORITISING THE ADOPTION OF YIELD OF NEIGHBOURING INSURANCE UNIT WHEN ADEQUATE CROP CUTTING EXPERIMENTs COULD NOT BE CONDUCTED

The Priority of applicability is notified as stated below:

- Priority 1 : Adopting the yield of a neighbouring Insurance Unit with maximum correlation
- Priority 2 : Adopting yield estimate of next higher unit

The decision of State Level Technical Advisory Committee (STAC) will be final in case of any disputes regarding adoption of yield of a neighbouring Insurance Unit.

XIV. SEASONALITY DISCIPLINE FOR PREVENTED SOWING / GERMINATION RISK

The District Level Monitoring Committee under the Chairmanship of District Collector is authorized to fix the seasonality discipline for prevented sowing / failed sowing by adopting the conditions formulated in the Revised Operational Guidelines. The Insurance Companies are also directed to make an appeal to invoke prevented sowing / germination risk only within prescribed period with proper evidence (i.e.) not later than 15 days from cut off date for enrolment of farmer for prevented sowing (Para 21.3.2.4 of Operational Guidelines) and not later than 3 weeks after peak sowing period in case of germination risk (G.O.(Ms).No.293, Agriculture (AP6) Department, dated 12.09.2016). The Insurance Companies shall also not make an appeal at any date later than the timeline fixed or after the receipt of yield data from the Department of Economics and Statistics.

In case, this provision is not invoked by the District Level Monitoring Committee / District Level Joint Committee, Insurance Company may escalate the same in writing to State Government within the stipulated timeline (Para 21.3.2.5. of Operational Guidelines). Insurance Companies shall use products viz., Satellite based Vegetation Index, Weather parameters, etc. or other technologies (including statistical test, crop models etc.) to decide about invoking of prevented sowing / germination risk within the stipulated timeline (as per Para 21.3.6.1.3 of Operational Guidelines) or to confirm the yield estimates when the yield estimates reported at IU level are abnormally low or high vis-à-vis the general crop condition (as per Para 19.2 of Operational Guidelines).

The Insurance Companies are also directed -

- a. to inform Agricultural Production Commissioner & Principal Secretary to Government, Agriculture Department / Director of Agriculture / Director of Horticulture & Plantation Crops if area sown details are not furnished in time.
- b. to disburse the claim for prevented sowing / planting / germination risk within 30 days of the State's order / notification invoking the event of the insured risk, subject to the data on estimated area sown having been received from State Government (Para 21.3.5.4. of Operational Guidelines).
- c. to disburse the pay-out under the cover without waiting for the receipt of final Government share of premium subsidy. (Para 21.3.5.5. of Operational Guidelines).

The Financial institutions are also directed to-

- a. ensure that they debit farmers' premium within 15 days from sanction/renewal of KCC/crop loan, failing which banks will be liable to meet the claim liabilities of uncovered eligible farmers. (Para 21.3.2.3. of Operational Guidelines).
- b. remit farmers' premium to Insurance Company, with loanee farmers list, within 7 days of intimation of loss under this section, if not uploaded earlier on Portal. However, this option must be exercised as last recourse with proper justification. (Para 21.3.5.9 of Operational Guidelines).

The Tamil Nadu Agricultural University is also directed-

- a. to provide Remote sensing based information and Crop Signatures on payment within 15 days period from the date of receipt of request by the notified Insurance Companies

XV. NOTIFICATION OF DISTRICTS FOR LOCALIZED PERILS, MID-SEASON ADVERSITIES AND POST HARVEST LOSSES

The following districts are notified for localized perils, mid-season adversity and post harvest losses as indicated below:-

XVI. APPLICATION OF REMOTE SENSING BASED INFORMATION & INSURANCE FOR CROPS IN EMERGING ECONOMIES (RIICE)

The Remote Sensing Based Information & Insurance for Crops in Emerging Economies (RIICE) Project of Tamil Nadu Agricultural University (TNAU) is notified for Computation of Area under Prevented Sowing for Paddy, Maize and Cotton during the 3 year contract period from 2019-2020 to 2021-2022. The Tamil Nadu Agricultural University is also directed to abide by G.O.(Ms) No.293, Agriculture (AP- 6) Department dated 12.09.2016 with regard to prevented / failed sowing risks and provide Remote sensing based information and Crop Signatures on payment within 15 days period from the date of receipt of request by the selected Insurance Companies.

XVII. DIGITIZATION OF LAND RECORDS

The Insurance Companies are directed to accept the e-adangal / Sowing certificate generated through e-adangal web service system as one of the documents to be enclosed with the proposal for enrolment once the process of issuance is finalized.

XVIII. APPLICATION OF AREA CORRECTION FACTOR (ACF):

The Insurance Companies are directed-

- to avoid application of Area Correction Factor if the difference between area insured and area sown is less than or equal to 30% at Block/ Tehsil / Taluk.
- to access to the final Area sown details provided by the Department of Economics & Statistics at the time of calculation of compensation claims. In case of differences more than 30% the Insurance Companies to abide para 25.3 of operational guidelines in referring to Mahalanobis National Crop Forecast Centre.
- to upload the data on application of Area Correction Factor on National Crop Insurance Portal.

XIX. REMITTANCE OF FARMERS' PREMIUM

The Government directs the

- bankers to ensure that the premium for both loanee and non-loanee farmers is remitted to concerned Insurance Companies and the related data uploaded on National Crop Insurance Portal within the prescribed time.

- Concerned Bank and its branches / CSCs shall be made liable to pay admissible claims to farmers if they fail to follow the procedure delineated in the Operational Guidelines.
- Insurance Companies to verify the applications, check the premium amount received, if necessary, get the proposals corrected by Financial Institutions / Common Service Centres, accept the corrected proposals and process the proposals within the timeline stipulated.
- Financial Institutions / ICs not to return back the premium to the farmers at any date later to the timeframe mentioned in the Guidelines.
- State Level Bankers Committee (SLBC) , Registrar of Co-operative Societies (RCS) & Insurance Companies to
 - furnish consolidated debit and remittance report of farmers' premium every month to Government for review by Agricultural Production Commissioner & Principal Secretary to Government , Agriculture Department.
 - upload the details of remittance on the software developed by Department of Agriculture on 28th of every month.

XX. COMBATING ENROLMENT MALPRACTICES UNDER PMFBY

The Government permits the stakeholders to display the names of the fraudulent farmers on the notice boards of enrolment centers besides debarring them from the Pradhan Mantri Fasal Bima Yojana scheme for atleast 6 seasons (2 years) to manage the risk of fraud. The Government also directs the Director of Agriculture / Director of Horticulture & Plantation Crops to address the District Collectors and Financial Institutions to debar the farmers from enrolling under Pradhan Mantri Fasal Bima Yojana and not to collect premium from such farmers.
