**ORDER:**

The Government of India in their letter first read above, had approved the Annual Action Plan 2016-17 of the National Horticulture Mission (NHM) under the Mission for Integrated Development of Horticulture (MIDH) at an outlay of Rs. 91.72 crore in the funding pattern of 60:40 between the Centre and State.

2. In the Government order second read above, the Government had sanctioned and released the first installment Rs. 45.83 crore, including the State matching share Rs.18.33 crore to implement the scheme of National Horticulture Mission (NHM) under Mission for Integrated Development of Horticulture (MIDH) during the year 2016-17.

3. In G.O. third read above, the Government had sanctioned and released a sum of Rs.7,72,50,000/- (Rupees Seven crore seventy two lakh and fifty thousand only) as second installment which includes Government of India share of Rs.4,63,50,000/- and State Matching Share of Rs.3,09,00,000/- towards implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2016-17 in Tamil Nadu.

4. In G.O fourth read above, the Government had sanctioned and released a sum of Rs.2391.87 lakh which includes Government of India share Rs.1500.00 lakh and State matching share Rs.891.87 lakh as third instalment towards the implementation of National Horticulture Mission for Integrated Development of Horticulture during 2016-17 and directed that the Director of Horticulture and Plantation Crops to send necessary proposal after 1.4.2017 to release the balance fund. Now, the Managing Director, Tamil Nadu Horticulture Development Agency has sent proposal and requested to release the balance amount State share of Rs.1,08,13,000/- for SCSP category as the pending third instalment for implementation of National Horticulture Mission (NHM) under Mission for Integrated Development of Horticulture (MIDH).

5. The Government after careful examination accept the proposal of the Director of Horticulture and Plantation Crops /Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release balance State share amount of Rs.1,08,13,000/- (Rupees one crore eight lakh thirteen thousand only) for SCSP Category towards implementation of the National Horticulture Mission (NHM) under Mission for Integrated Development of Horticulture (MIDH) during 2016-17.

6. The expenditure sanctioned in para-5 above, shall be debited in the following head of account:-

7. The Director of Horticulture and Plantation Crops is permitted to draw and disburse the amount sanctioned in para 5 above.

The Director of Horticulture and Plantation Crops is authorized to draw the amount and deposit the same in the PD account of Tamil Nadu Horticulture Development Agency by Contra Credit by following the procedures suggested in G.O.(Rt) No.1251, Finance (Ways and Means II) Department dated 30.12.2005 and G.O.(Rt) No.1253, Finance (Ways and Means II) Department, dated 30.12.2005.
