### ORDER:-

In their letter first read above, the Government of India have conveyed the approval of Annual Action Plan for implementation of National Horticulture Mission (NHM) programme under Mission for Integrated Development of Horticulture (MIDH) during 2016-2017 at an outlay of Rs.9424.6 lakh (including Rs.252.6 lakh Spill over activity/unspent balance) in the funding pattern of 60:40 between Central and State Government.

2. In their letters second read above, the Government of India have released a sum of Rs.27,50,00,000 as first installment (i.e) General category a sum of Rs.22,00,00,000, SCSP category a sum of Rs.5,22,50,000 and TSP category a sum of Rs.27,50,000 out of approved Annual Action Plan of Rs.9424.6 lakh under Mission for Integrated Development of Horticulture Scheme (MIDH).

3. In her letter third read above, the Director of Horticulture and Plantation Crops/Managing Director, Tamil Nadu Horticulture Development Agency has requested the Government to sanction and release a sum of Rs.45,83,33,300/- (Rupees forty five crore eighty three lakhs thirty three thousand and three hundred only) as first installment which includes Government of India share of

Rs.27,50,00,000 and State matching Share of Rs.18,33,33,300/- towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2016-17.

The Government, after careful examination, accept the proposal of the Director of Horticulture and Plantation Crops / Managing Director, Tamil Nadu Horticulture Development Agency and accordingly sanction and release a sum of Rs.45,83,33,300/- (Rupees forty five crore eighty three lakhs thirty three thousand and three hundred only) as first installment which includes Government of India share of Rs.27,50,00,000 and State matching share of Rs.18,33,33,300/- towards the implementation of National Horticulture Mission under Mission for Integrated Development of Horticulture during 2016-17.
