ORDER:-

In the Government Order first read above, the Government have sanctioned the continuance of the scheme for the Bio-Fertilizer Production Units for the period from 1.04.2015 to 31.3.2016 at a total cost of Rs. 1303.74 lakh.

2. In the Government Order second read above, the Government have sanctioned additional fund in the above scheme for wages & Transport charges Rs. 24.785 lakh and Rs. 107.454 lakh respectively.

3. The Commissioner of Agriculture in his letter third read above, has sent proposal for sanction of the continuance of the scheme for Bio-Fertilizer Production Units for the period from 01.04.2016 to 31.03.2017 as detailed below:-

4. The Government after careful examination has decided to accept the proposal of the Commissioner of Agriculture. Accordingly, the Government permit to continue the scheme for production and distribution of Bio-Fertilizer for the period from 01.04.2016 to 31.3.2017 and also accord to incur the budget allotment of Rs. 1307.92 lakh (Rupees Thirteen Crore Seven lakh and Ninety two thousand only) for the production of lignite based

Bio-Fertilizer 3000 MT and Liquid Bio-Fertilizer at 2,50,000 Litre subject to the recovery of expenditure in full, through sale amount and also permitted to incur expenditure of the sanctioned funds and to the adherence of Quarterly Control Appropriation (QCA).

5. The above expenditure shall be debited to the following head of account:-

"2402-00 Soil and Water Conservation – 101 Soil Survey and Testing – I Non Plan – AG preparation and Distribution of bacterial culture packets (DPC 2402-00-101-AG 0004)"

6. The sale of Bio-Fertilizer shall be credited to the following receipt head of account:
