### **ORDER:**

In the Government order first read above, orders have been issued sanctioning a sum of Rs.29.70 lakh for production and distribution of Blue Green Algae at Physical target of 525 MT and to permit to continue the scheme for the period from 1.4.2015 to 31.3.2016.

2. In his letter second read above, the Commissioner of Agriculture has stated that now a days priority is given for Organic farming and the Blue Green Algae is very much beneficial to the farming community and the soil fertility is also increasing by using them. He has, therefore, requested the Government to issue orders for continuance of the Blue Green Algae scheme for the period from 1.4.2016 to 31.3.2017 at a total cost of Rs.23.970 lakh for production and distribution of 525 MTs of Blue Green Algae.

3. The Government after careful examination, accept the above proposal of Commissioner of Agriculture and accordingly sanction a sum of Rs.23.970 lakh (Rupees Twenty Three lakh and Ninety seven thousand only) for production and distribution of 525 MTs of Blue Green Algae and to permit to continue the scheme for the period from 1.4.2016 to 31.3.2017 subject to recover the expenditure in full through sale price. From 2017-2018, the scheme shall be implemented under National Agricultural Development Programme.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"2415-Agricultural Research and Education 01-Crop Husbandry-004 Research I Non-Plan BE-Production and Distribution of Blue Green Algae".

5. The receipts from the sale of Blue Green Algae shall be credited to the following receipt head of account:-

6. The Commissioner of Agriculture is directed to send the progress report to Government periodically.
